### ELIGIBILITY CRITERIA

- ❖ Installed equipment must be on cooperative's lines and purchased in 2019.
- ❖ Participation in the load management program is required. A radio receiver will be installed free of charge on the electric water heater. The receiver conserves electricity by shutting off the water heater during peak demand times. Control times will vary depending on the size of the water heater.
- ❖ Rebate will be processed after the radio receiver is installed.
- ❖ Rebates are in place through December 13, 2019, or until funds are depleted. Funds are limited so members are encouraged to submit as soon as possible.
- ❖ Electric water heaters on special rates do not qualify for incentives.
- ❖ Members receiving a monthly water heater credit will forfeit the credit.
- ❖ Barron Electric reserves the right to deny or limit any rebate/incentive.
- ❖ All documentation listed below must be submitted no later than 3 months after purchase date, or by December 13, 2019, whichever date comes first.
