### ELIGIBILITY CRITERIA

Barron Electric Cooperative will give a free Siemens 30-A Level 2 VersiCharge electric vehicle charger to members who purchase an electric vehicle and meet the requirements listed below. This charges four times faster than Level 1. The charger works with all J1772 complying cars, as well as Tesla vehicles using Tesla's charging adapter.

- Member must schedule an appointment with Barron Electric to install the radio receiver and metering equipment within two months after receiving the electric charging station. If the appointment is not scheduled, the member will be billed for the full cost of the electric vehicle charger. Due date \_\_\_\_\_

- Not eligible for special rate.
- Equipment must be installed on cooperative's lines and will periodically be inspected and usage data collected from metering equipment.
- Program is in place through December 17, 2021 or while funds last.

- If the charging station is not installed correctly, neither Barron Electric nor the manufacturer will cover the cost of replacing or repairing the unit.
- Unit has a 3-year warranty for indoor or outdoor use. Please contact Siemens for any warranty questions.
- Proof of purchase of vehicle required
- Copy of registration form for vehicle required
- Required documentation listed below must be submitted no later than 3 months after purchase date for flow restrictor or smart WiFi power strip, and no later than 3 months after install date for electric vehicle charging station.
