## Electric Cooperatives Join Together to Develop EV Charging Stations

**B**arron Electric joined 28 electric cooperatives to create a regional electric vehicle (EV) charging network across Wisconsin, Illinois, Iowa, and Minnesota named CHARGE EV, LLC. The network includes over 30 Level 2 and Level 3 charging stations. The group of cooperatives is planning for future growth in EVs, and hopes to alleviate “range anxiety,” which is the concern some people have about traveling in an EV without a place to charge their vehicle.

“We are excited to be part of this opportunity to provide EV owners with peace of mind when driving from Iowa to northern Wisconsin, or from Minnesota to Illinois, knowing there are cooperative powered chargers available. We hope that will give people confidence to consider purchasing an EV and also encourage growth in the EV market,” said Barron Electric’s General Manager

Dallas Sloan. Sloan added, “We also recognize that 80% of charging is done at home. We offer a free charging station to those purchasing an EV.” See article below for more details.

The CHARGE EV infrastructure is just the start, as the group plans for additional investments in the EV market including member education on installing home chargers and encouraging members to test drive EVs.




## Free Charging Station from Barron Electric

Polymer is 90% lighter than porcelain and also has a longer life. Reclosers play an important role in the electric grid, as they shut off electric power if trouble occurs.

## Tatanka Ridge Wind Farm Achieves Commercial Operation

Dairyland Power Cooperative has a power purchase agreement with Tatanka Ridge Wind, LLC, for 51.6 MW of renewable energy. Dairyland's portion of Tatanka Ridge's output will deliver enough renewable energy to power approximately 16,000 homes. The facility's 56 wind turbines are located in Deuel County, S.D. The facility is owned by Tatanka Ridge Wind, LLC, which is jointly owned by Avangrid Renewables (15%) and WEC Energy Group (NYSE: WEC) (85%).

"Dairyland is pleased to work with Avangrid Renewables and WEC Energy Group on an efficient and sustainable facility that supports our transition to a

lower carbon future," said Brent Ridge, Dairyland President and CEO. "Diversification of resources is a key element of Dairyland's Sustainable Generation Plan, making Tatanka Ridge a valuable addition to our cooperative's renewable energy portfolio."

Tatanka Ridge encompasses approximately 18,000 acres of primarily corn and soybean farms and cattle ranches, leased from over 100

landowners. Between land lease payments and taxes, the wind farm will provide \$1.7 million of local economic benefits annually over the life of the project.

# \*Condensed Board Minutes

November 25, 2020



Arlyn Helm represents District 1 on Barron Electric's Board of Directors, which includes the following townships: Brooklyn, Gull Lake, Stinnett, Hayward, Scott, Casey, Trego, Springbrook, Bass Lake, and Rusk.



- Director Kessler gave the treasurer's report. A report of vouchers for the month was presented as part of the board packet as follows: #98266 thru #98340 of CCF Bank was in the amount of \$191,965 and capital credit estate checks in the amount of \$7,215. Director Kessler reported on activity of total receipts in the office - \$1,541,733; total receipts by wire and ACH - \$438,416 disbursements by ACH, EFT, wire - \$1,632,164; transfer of funds was made for payroll - \$194,431 and power bill paid 11/25/2020 in the amount of \$1,662,737.
- A membership list of 89 was presented and approved without objection by the board.
- Form 219 summarizing construction activity for the month of October in the amount of \$317,014.69 was presented for approval, and included new services - \$32,316.24; change jobs - \$23,787.62; miscellaneous - \$260,910.83 and 9 retirements. The Form 219 stood approved as presented.
- General Manager Sloan and Staff members Beaudette, Steines and Straw presented written and oral reports of their activities for the month.
- Outages through the month of October stand at 83,081 consumer hours off, which is 80.72% below 2019 hours of 430,906. Overtime year-to-date is 3,090 hours, which is 46.24% below 2019 hours of 5,748.25.
