DISTRICT 2 (Three-year term)

Incumbent Tim Kessler has filed notification of candidacy. District 2 includes the Town of Dewey in Burnett County; Towns of Barronett, Bashaw, Evergreen and Spooner in Washburn County.

Barbara Kromrey has volunteered with the St. Joseph Conference of the Society of St. Vincent de Paul for twelve years and currently serves as President. The Conference is dedicated to improving the lives of those struggling in Barron County through services offered by St. Vincent de Paul's Pantry and Kitchen and the St. Vincent de Paul Thrift Store. They provide invaluable community services, such as alleviating hunger, temporary shelter for displaced families, clothing and household items for those people in poverty, financial assistance, and more. In 2018, over 13,800 hot meals were served, over 444,000 pounds of food were used and/or distributed, and nearly 1,300 volunteer hours were provided. Clothing and household supplies helped 291 neighbors. Barbara remarked, "It is a great feeling to help those in need."

DISTRICT 4 (Three-year term)
Incumbent Scott Warwick has filed notification of candidacy. District 4 includes the Towns of Cumberland, Lakeland and Maple Plain in Barron County; Town of Roosevelt in Burnett County.

DISTRICT 8 (Three-year term)
Director Selmer Nelson has filed notification of non-candidacy. District 8 includes the Towns of Almena, Arland, Crystal Lake, Prairie Farm, Turtle Lake and Vance Creek in Barron County; Towns of Clayton and Clear Lake in Polk County; Towns of New Haven and Sheridan in Dunn County.

In order to be eligible for nomination by petition, each signature on the petition must be that of the individual in whose name the membership is held. Director nominees must reside within the district they are to represent. Members may call Barron Electric's office and request a petition or write their own.

If it is desired to have the

nominee's name on the printed ballot, it is necessary that the properly signed petition be received at the office of Barron Electric Cooperative, PO Box 40, Barron, WI 54812, no later than 12 o'clock noon, **Monday, February 10, 2020.**

If the nominee wishes to be on the biographical handout at the Annual Meeting, a photograph and biographical information needs to be submitted with the signed petition.

Resolutions

In order to make the Annual Meeting more orderly and to provide ample time for the membership to consider complex matters thoroughly, and because a resolution is generally a complicated motion requiring study and consideration, all formal resolutions which are to be presented to the meeting will, as in prior years, be reviewed by a Resolutions Committee prior to the Notice of the Annual Meeting being sent. This will not restrict the right of any member to make simple

motions at the Annual Meeting.

All resolutions must be in writing, properly signed, dated, and with the member's address and phone number. Hand-written resolutions will be considered only if legible as determined by the Resolutions Committee. Resolutions to be considered must be received no later than 12 o'clock noon on **Monday, February 10, 2020** and should be addressed as follows:

Cook's Corner

Hot Mexican Dip Linda Crossett

1 ½ lbs. lean ground beef
1 lb. Jimmy Dean regular sausage
2 lbs. Velveeta Cheese
3-4 oz. cans chopped green chilies
1-15 oz. can tomato sauce
1 small can tomato paste

Brown ground beef and sausage. Drain grease and return to large pan. Add 2 pounds Velveeta cheese cut in chunks, 3 (4 ounce) cans chopped green chilies, 1 (15-ounce) can tomato sauce, and 1 small can tomato paste. If you like it a little more spicy, you can add a 4 ounce can of chopped jalapeno peppers. Cook over low heat just until cheese is melted. Serve warm with Tortilla chips, corn chips or Fritos. This can be served in a crock pot on low heat.

*Condensed Board Minutes October 30, 2019

- Director Helm gave the treasurer's report, with comments by Manager Sloan. A report of vouchers for the month was presented as part of the board packet as follows: #96776 thru #96965 of CCF Bank was in the amount of \$266,093 and capital credit estate checks in the amount of \$22,901. Director Helm reported on activity of total receipts in the office - \$3,222,756; total receipts by wire and ACH - \$2,650,609; disbursements by ACH, EFT, wire - \$5,017,477; transfer of funds was made for payroll - \$199,611 and power bill paid 10/30/19 in the amount of \$1,919,905.
- A membership list of 79 was presented and approved without objection by the board.
- Director Baker reported on the DPC meeting he attended on October 17 & 18, 2019. Director Mandel reported on the Safety Meeting she attended on September 26, 2019. Directors Kessler and Mandel reported on the Credentialed Cooperative Director courses they attended on October 22 & 23, 2019. Director Bol reported on the Safety Meeting he attended on October 24, 2019. The directors reviewed the Monthly Safety Report from Denise Fox, Compliance Safety and Training Officer.
- Form 219 summarizing construction activity for the past month in the amount of \$160,579.76 was presented for approval, and included new services - \$16,564.34; change jobs - \$9,594.10; miscellaneous - \$134,421.32 and 0 retirements. The Form 219 stood approved as presented.
