- Director Helm gave the treasurer's report, with comments by Manager Sloan. A report of vouchers for the month was presented as part of the board packet as follows: #92880 thru #92992 of CCF Bank was in the amount of \$164,311 and capital credit estate checks of \$7,470. Director Helm reported on activity of total receipts in the office - \$820,841; total receipts by wire and ACH- \$870,754; disbursements by ACH, EFT, wire - 682,380; transfer of funds was made for payroll -\$87,508 and power bill paid 12/30/17 in the amount of \$2,292,178. A membership list of 60 was presented and approved without objection by the board.
- Form 219 summarizing construction activity for the past month in the amount of \$229,424.50 was presented for approval, and included new services - \$57,691.20; change jobs - \$25,614.56; miscellaneous - \$146,118.74 and 4 retirements. The Form 219 stood approved as presented.

### Assembly Bill 583 will Help Electric Cooperatives

Barron Electric Cooperative's General Manager, Dallas Sloan, provided testimony on Assembly Bill 583, introduced by State Representative Romaine Quinn and cosponsored by Senator Janet Bewley, to create a sales and use tax exemption for services furnished by one electric cooperative to another during a widespread outage. This bill recently passed on a voice vote, and will go to the Senate this month.

Dallas explained, "In 2017, Barron Electric experienced a difficult year of storms. Our total outage hours increased 132% over the previous four-year average. During the May 16 tornado, nearly 9,000 members were without power, which is just under 50% of our membership. Given the magnitude of this outage, Barron

Electric employed the help of seven other utilities and two contractors through Wisconsin's ROPE (Restoration of Power in an Emergency) program to help restore power. Barron Electric paid outside crews over \$120,000 for labor and equipment, plus nearly \$7,000 in sales and use tax. These outside crews worked side by side with our crews, yet we are not required to pay sales and use tax on our crews." Dallas commented, "We appreciate Representative Quinn introducing this bill and Senator Bewley's support, as well as their support of electric cooperatives. The cooperative is looking out for the best interests of our members. Public safety and power restoration are the top priorities." Representative Quinn's work on this bill will ultimately help save all rural electric cooperative members money.
