It Pays to be a Barron Electric Member

Cooperative Month has been celebrated annually in October for more than half a century. This year's theme highlights how co-ops are creating diverse, equitable and inclusive workplaces and boards, and how cooperatives can better meet the needs of their communities.

This year, Barron Electric gave \$1.1 Million in cashback credits to over 16,000 members. Barron Electric members eligible for cashback credits, also known as capital credits, received a credit on their August 2020 bill statement. Over \$30 Million has been returned since 1965.

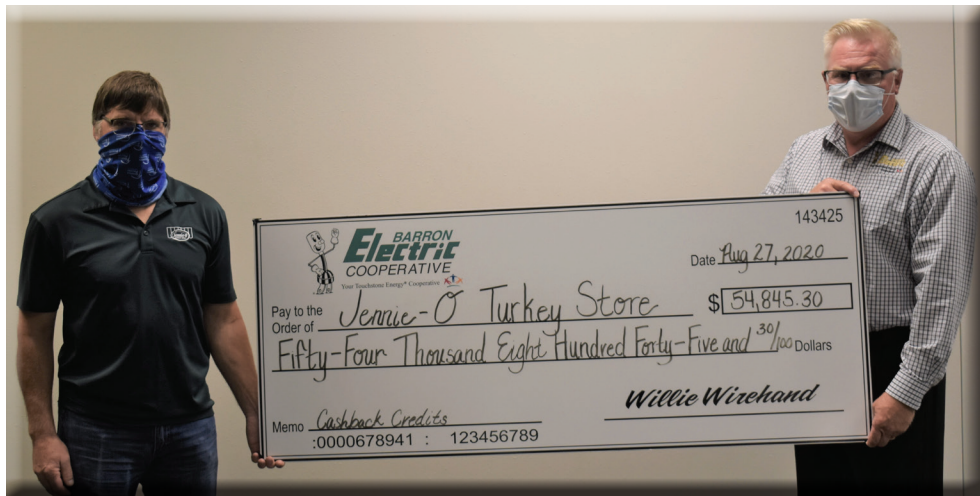
Unclaimed Capital Credits
Barron Electric tries to locate people who have not claimed their capital credits. The list of names can be found at barronelectric.com under the capital credits tab.

Commitment to Community
Barron Electric is committed to the communities they serve by donating to various non-profit organizations such as FFA, Girl Scouts, Boy Scouts, and the Boys & Girls Club. The cooperative has awarded more than \$320,000 in scholarships to high school seniors since the program began in 1985.



Low Rates
The cooperative has some of the lowest rates in the state when compared to other municipals, utilities, and cooperatives. There are several areas that have helped reduced costs including Right-of-Way Clearing, pole testing, maintenance projects, underground wire replacement, and utilizing technology.

Commitment to the Environment
Barron Electric and Nuto Farms teamed up to develop a butterfly garden to help the declining Monarch butterfly population habitat. Additionally, the cooperative's solar project has produced nearly 800 megawatt hours since energized in 2014. The system has saved 1.2 million pounds of CO2 emissions and is equivalent to planting over 9,000 trees.

Right-of-Way Clearing Helps Improve Reliability

The Right-of-Way Clearing Program helps reduce contact between trees and power lines. Trees and vegetation growing into the right-of-way can cause power outages, cause lights to blink, and become a fire and safety hazard. Contractors are hired to clear trees and brush in sixty-one townships on a rotational schedule of every five years for Barron County and every six years in Washburn County. Zielies Tree Service will be clearing the townships listed below starting in December. Call Before You Dig



Know what's below.
Call before you dig.

- An underground utility line is damaged once every six minutes nationwide because someone decided to dig without first calling 811. There are more than 20 million miles of underground utilities in the United States.
- Digging without knowing the approximate location of underground utilities can result in damage to gas, electric, communications, water and sewer lines, which can lead to service disruptions, serious injuries and costly repairs.
- Before you dig, notify your local 811. Your request needs to be made 2-3 days before you plan on digging.

*Condensed Board Minutes July 29, 2020

- Director Helm gave the treasurer's report. A report of vouchers for the month was presented as part of the board packet as follows: #97782 thru #97903 of CCF Bank was in the amount of \$747,116 and capital credit estate checks in the amount of \$10,424. Director Helm reported on activity of total receipts in the office - \$3,163,131; total receipts by wire and ACH - \$3,009,741; disbursements by ACH, EFT, wire - \$4,879,949; transfer of funds was made for payroll - \$305,039 and power bill paid 07/29/2020 in the amount of \$2,093,088.
- Form 219 summarizing construction activity for the month of June in the amount of \$330,053.42 was presented for approval, and included new services - \$14,248.65; change jobs - \$22,897.40; miscellaneous - \$292,907.37 and 2 retirements. The Form 219 stood approved as presented.
- Outages through the month of June stand at 33,527 consumer hours off, which is 28.20% above 2019 hours of 26,152. Overtime year-to-date is 1,309.75 hours, which is 30.36% below 2019 hours of 1,880.75.
