

2021 Charles Van Sickle Scholarship

The Federated Youth Foundation, Inc. is pleased to announce that it will award the fourth Charles Van Sickle Scholarship in 2021. The \$2,000 scholarship will be awarded to a pre-law or law student who has an interest in cooperative law. The scholarship is made possible by an endowment established in 2013 to honor Wisconsin's renowned electric cooperative lobbyist and attorney, the late Charles Van Sickle. The scholarship will be awarded during the Spring 2021 semester.

ELIGIBILITY

- Pre-law or law students who <u>reside in Wisconsin</u> and <u>have an interest in cooperative</u>
 <u>law</u> are eligible to apply. Preference will be given to students whose parents or
 grandparents are members of cooperatives, credit unions or mutual insurance companies.
- Applicants may be awarded this scholarship only once.
- Applicants must have a minimum cumulative grade point of 3.0 on a 4.0 point scale.
- Applicants will be judged on leadership, scholastic achievement, extracurricular activities
 while working on his or her undergraduate degree, personal motivation, academic and
 life goals.
- To be eligible, all areas of the application form must be filled out and submitted together.
- Attach to your application transcripts through your most recently completed semester (undergraduate or law school) and a copy of your Spring 2021 course schedule.
- Scholarship applications will be judged by a selection committee appointed by the Foundation.
- All applications are due at the Federated Youth Foundation office no later than **April 2, 2021.**

Please make sure to <u>return the following documents</u> to the Federated Youth Foundation by <u>April 2</u>, **2021**:

- a completed application form;
- a personal essay, 1 to 3 pages long in 12 point type;
- three reference letters, signed and in sealed envelpes;
- list your three references with their contact information;
- official grade transcripts; and
- your Spring 2021 course schedule.

Applications received after **April 2, 2021**, will not be considered.
