ELIGIBILITY CRITERIA

NOTE: Agricultural, Commercial and Industrial members that incorporate certain energy efficient equipment not listed below may qualify for a custom rebate. New and existing facilities are eligible. Please contact us for details.

- ❖ Rebate not to exceed 20% of the cost of equipment.
- ❖ Equipment must be installed in 2023 and must be on cooperative's lines.
- ❖ The incentive for qualifying rebates will appear as a bill credit unless the incentive is greater than \$200 in which case a check may be issued.
- ❖ Rebates are in place through December 15, 2023, or until funds are depleted.
- ❖ All documentation listed below must be submitted no later than 3 months after installation date, or by December 15, 2023, whichever date comes first.
