#### **Alternative Charger Requirements:**

- ☐ Equipment must be installed on cooperative's lines and may be inspected periodically.
- ☐ Members must participate in the load management program which interrupts charging from 2 p.m. − 9 p.m. *This Strategy is* not interrupted on weekend or holidays, except during a full load control.
- ☐ Members must schedule an appointment with Barron Electric to install a radio receiver before receiving the rebate.
- ☐ The Rebate cannot exceed the cost of the electric car charger and a receipt must be provided.
- ☐ Tesla NEMA plug/adapter does not qualify
