## ELIGIBILITY CRITERIA

- ❖ Equipment must be installed in 2024.
- ❖ Installed equipment must be on cooperative's lines.
- ❖ Rebate not to exceed 20% of the cost of the equipment.
- ❖ Rebates not allowed for a measure and a component of that measure. For example, if an air source heat pump has a variable speed blower motor, the air source heat pump qualifies for a rebate but not the variable speed blower motor.
- ❖ Rebates are in place through December 13, 2024, or until funds are depleted. Funds are limited so members are encouraged to submit as soon as possible.
- ❖ The incentive for qualifying rebates will appear as a bill credit unless the incentive is greater than \$200 in which case a check may be issued. Rebates greater than \$200 may be subject to an inspection performed by the cooperative.
- ❖ All documentation listed below must be submitted no later than 3 months after installation date, or by December 13, 2024, whichever date comes first.

  - ✓ AHRI certificate number
  - ✓ Documentation showing the equipment has been installed
