Members Hear How Participation Powers Progress at Barron Electric Cooperative's 87th Annual Meeting

embers attending Barron Electric Cooperative's 87th Annual Meeting on Saturday, March 25 heard how participation powers progress. Over 400 members and guests attended the meeting and enjoyed a breakfast served by the Barron VFW.

Clean Energy Ron Franz, Director of Resource and Energy Planning at Dairyland Power Cooperative, discussed beneficial electrification, which is a move towards using powered items including battery-operated tools, heat pump furnaces, and electric vehicles to create a cleaner and more affordable future.

He discussed the importance of the integrity of the electric grid during extreme weather. He indicated that nine states experienced rolling blackouts in December 2022 and the Midwest helped to keep the lights on.

Ron discussed the Nemadji Trail Energy Center, which is a cooperative effort among Minnesota Power, Dairyland Power Cooperative, and Basin Electric Power Cooperative. The hope is to start construction as early as this year. Together, they are building a state-of-the-art natural gas plant in Superior, Wisconsin, to ensure the delivery of safe, reliable and affordable energy for their customers and members.

NuScale Power and Dairyland Power are exploring NuScale's small modular nuclear reactor technology to help deliver safe, affordable, and carbon-free energy.

Financial Report Mandy Straw, director of finance, reported that operation revenue was up slightly from last year to \$39.5 million. The increase in the cost of power by \$2.58 million was the result of power cost adjustments reflecting an increase in the cost of energy inputs needed to generate electricity. Mandy indicated that the total cost of electric service was \$39.1 million. After expenses, other non-operating margins and other cooperative investments, Barron Electric allocated \$1.74 million in net earnings to its members. Straw added that net utility assets

increased to \$62.2 million and total assets were \$86.5 million at the end of 2022.

Manager's Report

General Manager Aaron Torud discussed the December 15 storm where heavy snow on trees left more than 9,000 members without power. He remarked, "It was an all-hands-on-deck storm with 70 additional personnel from other electric cooperatives, municipals, and contractors assisting Barron Electric."

Torud recognized the employees for their commitment to community thanking them for 190 hours of volunteer service and total donations of \$8,700 to non-profit organizations, which included a match from the cooperative. He also said the cooperative gave \$40,000 in additional donations to community organizations from its Federated Youth Foundation account, consisting of unclaimed capital credits. Organizations receiving funding included: Barron County 4-H Leaders, Boy Scouts Blue Hills, Boys and Girls Club, local FFA chapters, Girl Scout of the Northwestern Great Lakes, Northern Star Boy Scouts, NRECA International, Rice Lake Free Clinic, Rural Housing, high school scholarships, Washburn County 4-H, Hospice-Lakeview, Regional Hospice, and the youth tour.

Board President's Report Board President Randy Cook emphasized safety, reliability, and affordability. The cooperative



has been replacing underground wire, updating the infrastructure, and clearing the rights-of-way to increase reliability. Meeting with legislators to ensure they are working for the best interest of electric cooperatives has been instrumental in keeping rates affordable. Investing in technology and offering energyefficient programs and rebates has also helped members save money. Members heard that Barron Electric's American Customer Satisfaction Index Score of 80 is higher than the average for investor-owned utilities, municipals, and other electric cooperatives.

Director Elections Incumbents Tim Kessler, Scott Warwick, and Bill Effertz were re-elected to Districts 2, 4, and 8, respectively. At an organizational meeting following the annual meeting, the following board members were elected: Randy Cook, board president, Mike Baker, vice president, Tim Kessler, treasurer, and Scott Warwick, secretary. Mike Baker was selected as Barron's representative on the Dairyland Power Cooperative board.
