

88th Annual Meeting Focuses on Reliability

Members and guests attending Barron Electric Cooperative's 88th annual meeting learned more about Barron Electric's projects to increase reliability, as well as Dairyland Power Cooperative's mission to reduce their carbon footprint which includes advanced nuclear technology. Behind Every Meter is a Co-op Member was the theme of Barron Electric's annual meeting, which over 300 members and guests attended.

Jeremy Browning, Vice President of Generation at Dairyland Power Cooperative, discussed Dairyland's goal to reduce carbon emissions 50% by 2030. The Nemadji Trail Energy Center will help reduce that carbon footprint. Dairyland Power is also pursuing a non-carbon emitting 24/7 option through small modular reactors and advanced nuclear technology. Jeremy remarked, "Coal and gas are still needed during the transition." According to a report from the North American Electric Reliability Corporation, the reliability of conventional generation is signif cantly challenged by more frequent extreme weather, high-demand conditions,

and a changing resource mix, resulting in higher overall outage rates. Barron Electric's General Manager Aaron Torud said, "We are utilizing technology to enhance reliability, such as voltage/outage monitoring, transformer loading, and back-feed monitoring. The goal is to move towards proactive solutions to prevent service

Barron Electric donations are derived from the Federated Youth Foundation, an administrative trust overseeing unclaimed capital credits of former members.

- A report of vouchers for the month was presented as part of the board packet as follows: #102768 through #102841 from CCF Bank in the amount of \$152,991 and capital credit estate checks in the amount of \$25,726 Total receipts in the off ce \$2,410,184; total receipts by wire and ACH \$1,904,395; disbursements by ACH, EFT, wire \$3,586,444; transfer of funds was made for payroll \$214,934 and the power bill was paid on 02/28/2024 in the amount of \$2,370,388.
- A membership list of 37 was presented and approved without objection.
- Form 219 summarizing construction activity for the month of January in the amount of \$175,897.31 was presented for approval and included new services \$0 change jobs \$0. Other Work Order Projects \$175,897.31 and 2 retirements. The Form 219 stood approved as presented.
- Outages year-to-date stand at 855.65 consumer hours off, which is 66.39% below 2023 hours of 2,545.63. Overtime year-to-date is 72.50 hours, which is 31.92% below 2023 hours of 106.50.

Helping out in an Emergency

7 Then the call comes in asking for assistance in restoring power to members, linemen are ready to help. Members of Dairyland Power Cooperative participate in a mutual assistance program known as ROPE, Restoration of Power in an Emergency. When ROPE is activated, the cooperative in need covers all expenses. On April 3, Oconto Electric Cooperative, located north of Green Bay, Wisconsin, called in ROPE for assistance after a winter storm brought down trees and power poles, which left more than 9,000 Oconto Electric members without power. Barron Electric sent four linemen: Jason Kircher, JT Gunderson, Nate Gustum, and Tim Engel, to help restore power. Barron Electric Leadman/ Technician Nate Gustum said, "We helped run new lines across U.S. Highway 141 to restore power to several members. Deputies and **Emergency Management helped** provide traff c control for line crews." Crews worked 16-hour days from April 3-7, until power was restored.

Barron Electric has utilized ROPE three times since 2017: 2017 Chetek tornado, 2019 Derecho, and the December 2022 winter storm. ROPE is an example of the 6th Cooperative Principle, Cooperation Among Cooperatives.

Global Mapping Solutions (GMS) has started working on Barron Electric's system. GMS will be on members' property



to inventory and take pictures of equipment, i.e. meters and transformers. Their vehicles will display signs with Barron Electric's logo, and GMS crews will carry identif cation badges noting they are contracted by Barron Electric.

Pole Testing American Energy Services is testing poles in Bear Lake, Dallas, Prairie Farm, Stanfold, and Vance Creek in Barron County, as well as New Haven and Sheridan Townships in Dunn County, and Birchwood Townships in Washburn County. A sign that displays Barron Electric Cooperative's name will be displayed on their vehicles, while a 4-wheeler may be used to move eff ciently throughout the system. interruptions and outages." Barron Electric has built two substations to help with the increased load in our service territory. Randy Cook, Barron Electric's Board President, told members that the cooperative has the third lowest rates when compared to local utilities. He remarked, "The f nancial and overall operation of Barron Electric is very strong." The Board of Directors provides guidance on the strategic plan and the budget process, while also ensuring the cooperative provides a safe environment for both employees and members.

Director elections were held for Districts 1, 5, and 7. Incumbent Dave Olson, running unopposed, was reelected to District 1. In District 5, John Blaskowski and Incumbent Larry Kuhl both submitted their nomination forms. John Blaskowski was elected to District 5 with 86 votes, while Larry Kuhl received 70 votes.
