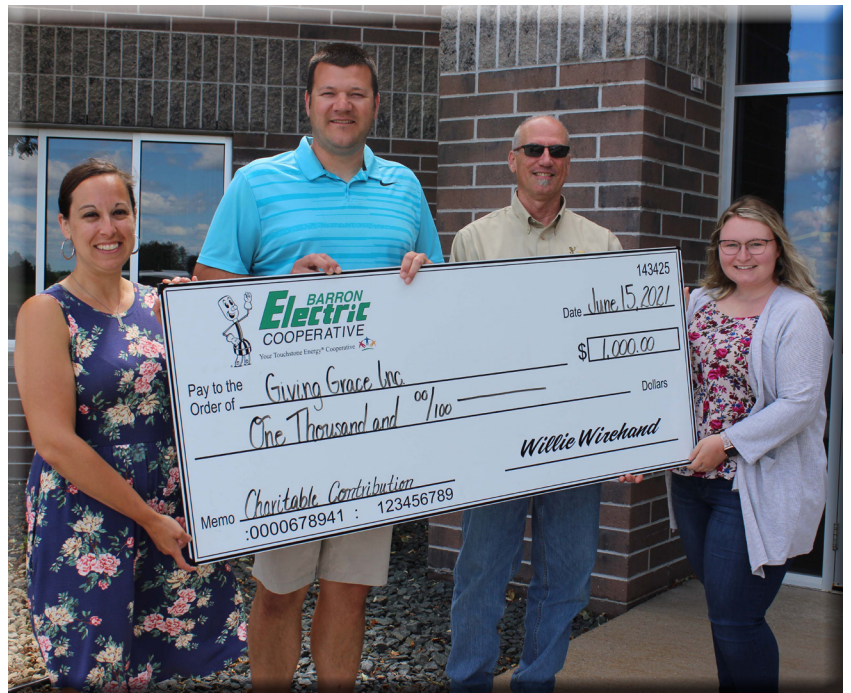

Members to Share \$600,000 in Cashback Credits

Credit Included on August Bill Statement

Barron Electric Cooperative's Board of Directors approved retiring \$600,000 in Cashback Credits, also known as capital credits. Barron Electric will retire cashback credits for the year 2001 at 100% of the remaining balance of the cooperative portion and for the year 2002 at 43% of the cooperative portion.

Over 6,000 current members eligible for a capital credit check will see a credit on their August bill statement. Former members eligible for cashback credits will receive a check.

Cashback credits reflect the member's contribution of capital to the cooperative. The capital provided by members help us keep rates low and reduces the amount of money needed to borrow from outside lenders to build, maintain, and expand a reliable electric distribution system. Barron Electric will be combining the annual meeting with cooperative month events to help reduce exposure to COVID-19.

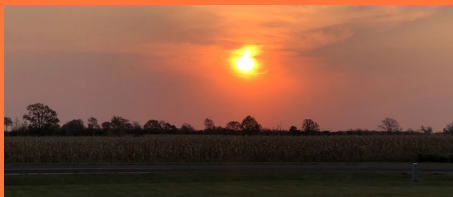

• Director Kessler gave the treasurer's report, with comments by Interim General Manager Olson. A report of vouchers for the month was presented as part of the board packet as follows: #98894 thru #99024 of CCF Bank was in the amount of \$686,944 and capital credit estate checks in the amount of \$14,869. Director Kessler reported on activity of total receipts in the office -

\$1,694,209; total receipts by wire and ACH - \$256,874; disbursements by ACH, EFT, wire - \$1,076,164; transfer of funds was made for payroll - \$185,245 and power bill paid 05/26/2021 in the amount of \$1,688,128.

- Form 219 summarizing construction activity for the month of April in the amount of \$84,724.27 was presented for approval, and included new services - \$6,098.38; change jobs - \$6,231.60; miscellaneous - \$72,394.29 and 1 retirement. The Form 219 stood approved as presented.
