

### Is an Electric Vehicle Right for You?

With the price of gas at an all-time high, you might be considering an electric vehicle (EV). A gas car, which gets 25 miles per gallon, will cost 18 cents per mile at \$4.50 per gallon, while an electric vehicle, based on Barron Electric's rate of 10.57 cents per kilowatt hour, will cost 3.5 cents per mile. Electric vehicle owners say EVs are responsive, require minimal maintenance and are fun to drive. Plus, there are no oil changes to schedule. Prices for EVs are becoming more competitive with many EVs starting under \$40,000.

Surveys indicate that 80% of EV charging occurs at home, which means you should be able to do most, if not all, of your charging overnight at home. EV public charging infrastructure continues to increase. Barron Electric has EV charging stations at their Barron and Spooner office locations, and a fast charger and Level 2 charger were installed at the Prime Bar & Family Dining in Trego. DC fast chargers charge most EVs up to 80% within 30-60 minutes. Check out plugshare.com for the nearest public charging station.

You may wonder why Barron Electric is promoting electric vehicles and electric charging stations since this will add more demand to the grid. Many of the new EVs will charge at night during off-peak hours. In the future, EVs will have the ability to put power on the grid during peak hours.

#### Free Level 2 Electric Vehicle Charger

Barron Electric offers a free Level 2 electric vehicle charger to members who purchase an electric vehicle. The charger works with all EVs, including Tesla vehicles, using Tesla's charging adapter. The cooperative requires charging at night when demand for electricity is low. Visit barronelectric.com and click on the rebate tab for more details.



## The Importance of KW Demand

Coming soon, members will see KW Demand on their billing statement. What does this mean? Demand is the maximum requirement of electricity needed at any given time. Imagine putting marbles in a tube. If you only have one tube (or power line), only so many marbles are going to flow through the tube at any given time. In general, the more electrical devices that are operating at one time, the higher the demand as indicated on the image to the right.

#### Why is demand important?

Barron Electric must plan for future growth and design electric power lines, transformers, substations and other equipment to supply the maximum requirement of electricity by all members. Dairyland Power Cooperative, our wholesale power supplier, can use this data for strategic planning purposes.

## **Cooperative Receives Nearly** \$60,000 in REAP Grants

Barron Electric received nearly \$60,000 in Rural Energy for America Program (REAP)grants for updating over 1,000 dusk-to-dawn lights with LED (light-emitting diodes) fixtures, saving over 340,000 kilowatt hours. LEDs are more energy efficient than existing high pressure sodium and mercury vapor lights, saving an estimated 70% in energy costs. They also last longer, with a lifespan of 10 to 20 years, which saves on repair and replacement costs. LEDs provide a whiter light that shines downward improving visibility. Using LEDs is one way to save energy.

• Director Kessler gave the treasurer's report, with comments by General Manager Torud. A report of vouchers for the month was presented as part of the board packet as follows: #100308 thru #100408 of CCF Bank in the amount of \$258,772 and capital

credit estate checks in the amount of \$28,372. Director Kessler reported on activity of total receipts in the office - \$2,076,459; total receipts by wire and ACH - \$142,080; disbursements by ACH, EFT, wire – \$1,972,197; transfer of funds was made for payroll – \$197,888 and power bill paid 05/25/2022 in the amount of \$1,914,909.

- A membership list of 59 was presented and approved without objection by the board.
- Form 219 summarizing construction activity for the month of April in the amount of \$76,664.77 was presented for approval and included new services \$645.88; change jobs \$12,781.06; Other Work Order Projects \$63,237.83 and 3 retirements. The Form 219 stood approved as presented.
